Role	Examples
Lookout	A Competent Worker responsible for keeping watch for approaching rail traffic and for warning other workers to stand clear of the line and move to a Safe Place
	before the rail traffic arrives.
Protection Officer	The Competent Worker responsible for managing the rail safety component of worksite protection.
