Role Descriptors	
A grade Electrician	An Electrician's licence entitles the licence holder to carry out all types of electrical installation work in Victoria without supervision.
Restricted Electrical Worker's licence (REL)	<p>The Restricted Electrical Worker's licence (REL), previously known as 'D' licence, entitles the licence holder to perform low-voltage electrical disconnect and reconnect electrical installation work relating to:</p> <ul style="list-style-type: none"> - equipment that is connected to a fixed electrical installation, - associated with a primary trade, vocation or occupation, and would otherwise require the services of a registered electrical contractor or a licensed electrician. <p>This licence type only allows the disconnection and reconnection of 'like for like' equipment, for the purposes of repair, replacement or maintenance.</p> <p>The Restricted Electrical Worker's licence does not allow a person to carry out electrical wiring and installation work at low voltage or above, including the installation of new wiring or equipment. All fixed electrical installation work requires a licensed electrician.</p>
Electrical Inspector (LEI) - Vic	<p>Class G allows an inspector to undertake inspections of any low voltage installations, except for those required under Class H, Class M, or Class V.</p> <p>It is expected that prospective applicants will have held an Electrician's Licence for at least five years.</p> <p>Applicants should be able to demonstrate their qualifications, experience, competency and proficiency in:</p> <ul style="list-style-type: none"> - a detailed understanding of safety in electrical installations that are covered by this class - testing methods for electrical installations that are covered by this class and - the requirements of the Regulations relating to low voltage electrical installations.
Electrical Supervised Worker's licence (L) Vic	<p>The holder of a Supervised Worker's licence (L) is entitled to carry out all electrical installation work in Victoria under the effective supervision of a licensed electrician (in accordance with any further conditions on the licence).</p> <p>This licence is issued for a maximum of three years and may not be renewed.</p>
Electrician (Supervised) Worker's (ES) Vic	<p>This licence is only available to people who have previously held a B-Grade licence and have continued to renew their licence every five years.</p> <p>An Electrician (Supervised) Worker's licence is issued for a period of up to five years and entitles the holder to carry out all electrical installation work in Victoria under the supervision of a licensed electrician.</p>
Electrician Switchgear Worker (SW)	The holder of a Switchgear Workers licence (SW) is entitled to carry out electrical installation work that is limited to the assembly, alteration, repair and maintenance of switchgear and control gear assemblies.
Electrical Contractor Licence	<p>A contractor licence allows you to contract and advertise to do work. You can only do the types of work described on your licence card. Contractor licences can be issued to individuals and to companies and partnerships.</p> <p>You can apply for a 1, 3 or 5 year licence.</p>
Electrical Qualified supervisor certificate NSW	<p>A qualified supervisor certificate allows you to supervise and do the work described on your certificate. Qualified supervisor certificates are only issued to individuals. A qualified supervisor certificate does not allow you to contract for work.</p> <p>You can apply to have a qualified supervisor certificate issued for 1, 3 or 5 years.</p>
Electrical Endorsed contractor licence NSW	<p>An endorsed contractor licence is issued to individuals who apply for a contractor licence and who also have the qualifications and experience needed to be a qualified supervisor.</p> <p>Endorsed contractor licence cards have 'contractor licence (Q)' printed on them to show they are also equivalent to a qualified supervisor certificate.</p>
Electrical mechanic - Qld - National	<p>Open electrical work licence.</p> <p>An electrical mechanic can perform all electrical work, such as:</p> <ul style="list-style-type: none"> - install or change an overhead electrical line - install electrical wiring - repair any electrical equipment - testing and commissioning of electrical apparatus
Electrical linesperson Qld - National	<p>Allows you to perform all electric line work, such as:</p> <ul style="list-style-type: none"> - building or maintaining an overhead electric line - testing of overhead electric lines

Restricted electrical licence Qld - National	<p>This licence limits you to specific electrical work associated with work from another trade or calling.</p> <p>Your need to perform electrical work must be legitimate; saving time or money are not good enough reasons.</p> <p>Examples of trades and callings that may be eligible for a restricted electrical work licence include:</p> <ul style="list-style-type: none"> - Refrigeration and air-conditioning technicians - Motor and armature rewinders - Electronics technicians - Gas fitters working on gas appliances - Instrumentation and process control technicians - Mechanical fitters disconnecting/reconnecting electric motors - Plumbers working on hot water systems - Electronics and telecommunications technicians
Electrical fitter Qld - National	<p>Allows you to perform electrical equipment work, such as:</p> <ul style="list-style-type: none"> - rewinding and repairing an electric motor - building and assembling a switchboard - maintain/repair electrical equipment.
Electrical joiner Qld - National	<p>Allows you to perform limited specialist installing, jointing and terminating electrical cables and work relating to electrical cables and equipment, such as:</p> <ul style="list-style-type: none"> - limited specialist installing, jointing and terminating of electrical cables - jointing and terminating a high voltage cable.
Electrical work training permit Qld - National	<p>This is a restricted permit which allows electrical work to be performed under specified conditions while you are being trained.</p>
