



Metro Academy Notification of Fees

Purpose

The objective of this bulletin is to advise changes to course fees from 01 July 2026

Background

Metro Academy offers 35 short courses, these are a combination of initial and renewal of the competencies required for Rail Safety Workers to perform their duties safely on the MTM Metropolitan Network.

These fees have been reviewed in line with commencement of the 2027 Financial year.

Course Variations

Course Type	Description
Initial	<p>This is for a learner to attain a new competency</p> <ul style="list-style-type: none"> On the provision that the pre-requisite requirements documented in A1626 'Work on Track' Safeworking Competency procedure have been met and; No AQF Statements of Attainment from another RTO for this competency have been issued. <p><i>Noting: GST is not applicable if the RTO issues a Statement of Attainment</i></p>
Renewal	<p>This is for a learner to maintain a competency</p> <ul style="list-style-type: none"> typically completed every 24 months.
Online	<p>Delivery of training and/or assessment that does not require a learner to attend in person and may be any of the following:</p> <ul style="list-style-type: none"> Attainment of a new competency Renewal of an existing competency A pre-requirement to attending face to face training to attain or renew a competency <p>There may be requirements for a learner to provide evidence of currency on the MTM Network.</p>
MTM Conversion	<p>This pathway is for learners that are attending initial training, specifically in the instance of:</p> <ul style="list-style-type: none"> Learners not approved to use a competency on the MTM Metropolitan Rail Network that have already attained the required AQF Statements of Attainment from a non-approved MTM training provider. Learners that have already attained some, but not all the AQF Statements of Attainment required for the competency. <p>This course is required to provide MTM Metropolitan Rail Network specific knowledge.</p>

Safety Observations	<p>This pathway is for Safety Advisors or non-operational roles i.e., Administrators, Managers, etc... to observe training sessions for the purpose of obtaining an awareness of Safeworking procedures within the MTM Metropolitan Rail Network, in these instances:</p> <ul style="list-style-type: none"> • No assessment is completed by the Training Officer on the Learner • No issuance of Qualifications or Competencies by Metro Academy to the Learner <p>For bookings, please direct queries to metroacademy@metrotrains.com.au</p>
Split-Fees	<p>Applicable for courses that have fees more than \$1,500.</p> <ul style="list-style-type: none"> • Complying with 2025 Standards for RTOs, Part 2, Division 3 - Accountability (Pre-paid fee protection measures), RTOs must not take a deposit of greater than \$1,500 from a learner prior to course commencement when an AQF Statement of Attainment is issued. • In instances where course fees exceed \$1,500, an initial deposit of \$1,500 or less is required and the balance is due within five (5) business days of the course commencing.
