# Purpose

The Bulletin is to advise the 2023 face-to-face renewal training dates to Third Party and MTM Track Force Protection Coordinators 3.3 (TFPCs).

# Background

The 'Work on Track' Safeworking Competencies procedure details the requirements relating to the reassessment period in which a competency must be renewed to remain current and valid on the MTM Metropolitan Rail Network for rail safety courses.

"Work on Track' Safeworking competencies must be renewed within two (2) years of their initial or renewal currency date. Individuals are required to complete the training and assessment as part of their ongoing competency maintenance (renewal) with Metro Academy.

Due to the COVID-19 outbreak and non-availability of a TFPC 3.3 facilitator, MA has been offering an online TFPC 3.3 renewal as an interim solution for the industry. The TFPC 3.3 online renewal endorsed the competency for six (6) months as informed by the risk assessment conducted with relevant stakeholders.

# **TFPC 3.3 Face-to-Face Renewal Training**

MA is offering face-to-face TFPC 3.3 Renewal training sessions at Metro Academy. The sessions can be purchased and booked via The Platform. Individuals will be required to complete face-to-face training and an assessment as part of ongoing TFPC 3.3 competency maintenance (renewal).

Following the completion, Metro Academy will be endorsing the individual's TFPC 3.3 competency for a further two (2) years. Find below scheduled sessions that will be available for the industry in 2023:

- 17 February 2023,
- 24 March 2023,
- 12 May 2023,
- 19 May 2023, and,
- 23 June 2023.

Additional face-to-face TFPC 3.3 Renewal sessions for late 2023 will be released on The Platform and it is recommended for industry to check The Platform for available dates.

<u>Note:</u> You will need to book in to a TFPC 3.3 online renewal session if you are unable to secure a seat into a faceto-face session prior to competency expiration.

TFPC 3.3 online renewal training is still available on The Platform and will allow TFPC 3.3s to remain current and valid for only six (6) months.
