Note 1 - The minimum required competency for a rail safety worker entering the Adelaide Metropolitan Passenger Rail Network (AMPRN) is SA Rail Commissioner Operator.													
Note 2 - Rail Operators have specific access requirements, therefore if you have obtained this unit of competence from a training provider not endorsed by the Rail Commissioner you may require further training.													
Note 3 - Torrens Connect Operational Rail Induction (ORI) will be accepted as equivalent competency to Safety Access the Rail Corridor (SARC) until 17 May 2026. After 17 May 2026, all rail safety workers requiring network access must hold SARC.													
Note 4 - Those working on train network must complete the train line specific training and those working on the tram line must complete the tram line specific training.													
Note 5 - Valid AMPRN Rail Safety Induction or Torrens Connect Operational Rail Induction (ORI) are considered equivalent to SA Rail Commissioner Rail Safety Induction. When a worker's current competency expires, they must then complete the new SA Rail Commissioner Rail Safety Induction.
